#### 1. COMMAND COMPOSITION AND ORGANIZATION:

JOUETT (CG 29) IS AN ANTI-AIR, ANTI-SURFACE, ANTI-SUBMARINE CRUISER, UNDER THE IMMEDIATE SENIOR COMMAND COMMANDER CRUISER DESTROYER GROUP FIVE (COMCRUDESGRU 5), AND IS HOMEPORTED AT SAN DIEGO NAVAL STATION, SAN DIEGO, CA. IN 1991, THERE WERE NO UNITS UNDER JOUETT'S OPERATIONAL OR ADMINISTRATIVE CAPTAIN J.J. NEGIN COMMANDED FROM 1 JAN UNTIL 8 JAN AND CAPTAIN F.A. WEEKS FROM 8 JAN UNTIL 31 DEC. ONE H-2 HELOCOPTER AIRCRAFT, SEASNAKE 10, WAS ASSIGNED TO JOUETT FROM HSL 33, NAS, NORTH ISLAND, SAN DIEGO CA.

NOV: SUPPLY MANAGEMENT ASSESSMENT (SMA) A ONE WEEK INSPECTION OF THE SUPPLY DEPARTMENT. A GRADE OF SATISFACTORY WAS GIVEN. THE 3M INSPECTION WAS GIVEN TO THE SHIP AT THE SAME TIME WHICH WAS ALSO SATISFACTORY.

DEC: GAPPED BILLET FOR AN MSC FILLED BY MSC J. RICKERT. FOOD SERVICE OPERATION BEGINS TO IMPROVE IMMEDIATELY. JOUETT WAS NAMED ONE OF THE FINANCIAL MANAGERS OF THE YEAR BY COMNAVSURFPAC.

### CG DIVISION

THE YEAR 1991 STARTED OUT WITH THE SHIP BACK FROM DESERT SHIELD AND IN STAND-DOWN. JUST BEFORE SRA, USS JOUETT SORTED OUT AND SHOT NGFS OBTAINING A SCORE OF 92 OVERALL. THE MAGAZINES WERE DOWNLOADED FOR SRA AT WEPSTA, SEAL BEACH, CA.

DURING SRA, TWO ORDALTS WERE INSTALLED IN THE GUNMOUNT, ONE IN THE EMPTY CASE TRAY, THE OTHER FOR THE GUNPORT SHIELD. THE ORDALTS WERE PERFORMED ADEQUATELY BY SIMA ORDALT SHOP. THE 5-INCH MAGAZINE, GUNHOUSE AND SMALL ARMS MAGAZINE RECEIVED A COMPLETE PAINTING OUT. CIWS AND THE MK68 GUN FIRE CONTROL RECEIVED ORDALTS IN THE ENVIRONMENTAL CONTROL UNIT AND TRANSMITTER, RESPECTIVELY.

IN JUNE, THE FIRST TASKING WAS THE CHANGE OF COMMAND FOR COMCRUDESGRU 5. ONCE AGAIN, CSG1 PERFORMED FLAWLESSLY RENDERING TWO 11-GUN SALUTES AND ONE 15 GUN SALUTE DURING THE CEREMONY. VERBAL PRAISE WAS EARNED BY BOTH COMNAVSURFPAC AND CCDG 5.

PROPS FOR TRE AND REFTRA KEPT THE SHIP BUSY THROUGHOUT JUNE, JULY AND AUGUST. THEY PAID OFF FOR CG DIVISION, WHICH EARNED AN

OUTSTANDING GRADE OVERALL. THE 5" GUN AND FIRE CONTROLMEN, CIWS TECHNICIANS AND LOADER CREW, AND .50 CALIBER TEAMS ENTERED INTO REFTRA FULLY PREPARED. DURING REFTRA, THE TRAIN ELECTRIC MOTOR SUFFERED A CASUALTY, THEREBY MAKING IT INOPERATIVE. CSG1, WITH THE HELP OF SIMA RIGGER SHOP AND NO OUTSIDE TECH ASSISTANCE REMOVED AND REPLACED THE ELECTRIC MOTOR IN A HARDWORKING TWO DAY MARATHON CHANGEOUT. TWO DAYS LATER AN ASU-8-B-SF WAS SUCCESSFULLY COMPLETED. THIS EARNED THE "SELF SUFFICIENT SHIP OF THE WEEK" AWARD FROM COMNAVSURFPAC AND A PASSING GRADE FOR THE GUNNERY PORTION OF REFTRA.

IN OCTOBER, TRANSITING TO SAN FRANCISCO FLEETWEEK, THE 5"/54 AND CIWS CREWS EXERCISED SEVERAL ANTI-SURFACE AND AIR EVENTS WITH THE RANGER CARRIER BATTLE GROUP.

USS JOUETT RETURNED TO SAN DIEGO TO COMPLETE A 3M AND INSURV INSPECTION, IN WHICH THE DIVISION EXCELLED. CSRR AND SESI IMMEDIATELY FOLLOWED WITH THE SAME RESULTS. ALSO, PREPS WERE UNDERWAY FOR CSA. CSRR WAS A SUCCESS WITH COMBAT SYSTEMS DEPARTMENT DOING SO WELL THE ISIC DECIDED THAT CSA WAS COMPLETED DUE TO ALL OUR PERFORMANCE IN PREVIOUS TASKING.

SEVERAL HUNDRED ROUNDS OF 5" AMMO WERE EXPENDED ALSO FOR NGFS SPOTTER OPS AND FIREX II NGFS QUALIFICATIONS. THE GUN PERFORMED VERY WELL WITH ONLY TWO MINOR CASUALTIES.

CIWS SHOT DOWN A TOWED SLEEVE DURING ALL COMER'S AT SEA TRAINING IN DECEMBER (AAW-12-SF).

### CA DIVISION

THE YEAR STARTED OUT WITH JOUETT'S RETURN FROM OPERATION DESERT SHIELD. THE SHIP WENT TO NAVWEPSTA LONG BEACH FOR DOWNLOAD OF THE TORPEDO MAGAZINE IN PREPARATION FOR SRA '91 IN SAN DIEGO.

DURING SRA '91 A REPAIR, ALIGNMENT AND CALIBRATION (RAC) WAS PERFORMED ON THE AN/SQS-26BX SONAR SET. SHIP'S FORCE, ASSISTED BY NAVSEACENPAC, PERFORMED A FIRE CONTROL REPAIR, ALIGNMENT AND CALIBRATION (FRAC) ON THE MK 114 UNDERWATER BATTERY FIRE CONTROL SYSTEM. ADDITIONALLY, THE HELICOPTER HANGER AND FLIGHT DECK WERE OVERHAULED BY CA DIVISION TO INCLUDE ALL NETS AND RIGGING.

FOLLOWING SRA '91 JOUETT'S FIRST TASKING WAS COMMANDER CRUISER DESTROYER GROUP FIVE CHANGE OF COMMAND. THE METICULOUS CONDITION OF THE HELICOPTER HANGER AND FLIGHT DECK EARNED FAVORABLE COMMENTS FROM CCDG 3 AND STAFF AS THE "BEST ON THE WATERFRONT".

THE SHIP'S INSPECTION CYCLE COMMENCED STARTING WITH TRE. THE DIVISION'S EFFORT PAID OFF WITH OUTSTANDING RESULTS DURING REFTRA '91 WITH ALL ASW EVENTS SCORING 95 PERCENT AND HIGHER, INCLUDING A FIRING ASROC REXTORP EXERCISE GRADED AS "OUTSTANDING".

FOLLOWING A HIGHLY SUCCESSFUL TESTING PERIOD FOR THE HARPOON BLOCK 1D, A PORT VISIT TO SAN FRANCISCO FOR "FLEET WEEK" '91, THE

SHIP RETURNED TO SAN DIEGO AND BEGAN PREPS FOR COMBAT SYSTEMS READINESS REVIEW (CSRR), COMBAT SYSTEMS ASSESSMENT (CSA), 3-M INSPECTION AND SUPPLY MATERIAL ASSESSMENT (SMA) AND INSURV.

THE 3-M ASSESSMENT WAS OUTSTANDING AND CA DIVISION PERSONNEL RECEIVED COMMENTS FROM INSPECTORS ON THE PROFESSIONAL CONDUCT DURING SPOT CHECKS. DURING CSRR ALL MINOR DISCREPANCIES WERE CORRECTED ON THE SPOT. LIKEWISE, THE DIVISION DILIGENTLY CORRECTED ALL DISCREPANCIES NOTED BY INSURV INSPECTORS. THE QUICK RESPONSE AND "CAN DO" ATTITUDE OF THE DIVISION PAID OFF RESULTING IN JOUETT'S CSA BEING VALIDATED BY THE CSRR AND INSURV. A FIRST FOR ANY WEST COAST SHIP.

THE DIVISION ENJOYED A WELL DESERVED HOLIDAY LEAVE AND UPKEEP PERIOD FOR THE REMAINDER OF 1991.

- 1. In accordance with references (a) and (b), USS JOUETT is nominated for this award. From 01 October 1990 to 30 September 1991, USS JOUETT has excelled in all areas of Combat Readiness. JOUETT has significantly improved and continuously demonstrated superior operational, administrative, material and readiness performance throughout this past fiscal year. Consistently improving on excellence throughout the last twelve months, every area of shipboard life has been exercised, tested and proven superior. Of particular note, JOUETT entered the fiscal year with only two of nine mission area awards. In the most recent competitive cycle JOUETT successfully completed the requirements for and was awarded six of nine mission area awards. JOUETT's ability to fulfill operational commitments, assignments, and tasks in normal day to day operations, exercises and contingencies is unsurpassed.
- 2. The following information regarding notable achievements by USS JOUETT during fiscal year 91 is forwarded:
- a. October 1990 Operation Desert Shield JOUETT started fiscal year 1991 with continued operations in support of Operation Desert Shield. For the following three months JOUETT made it's presence felt along with Battle Group Delta by tracking, identifying and, when necessary, intercepting all air and surface contacts transiting the Gulf of Oman and surrounding airspace. JOUETT played a pivotal role in providing unparalleled AAW coverage for Battle Group Delta assuming the duties as force AAWC and Link 11 Coordinator. In this role the ship directed the AAW actions of not only the ship's and air wing of Battle-Group Delta, but also those of the ship's and aircraft from the U.N. Coalition forces who were aiding in the enforcement of the economic sauctions against Iraq and Providing a clear picture of all air traffic from Central Iran to the Southern Border of Oman, JOUETT maintained it's motto of "Eternal Vigilance" by daily deconfliction of the Iranian P-3 Maritime aircraft patrol missions. Additionally, JOUETT sorted out the heavy air traffic in the Bandar Abbas air corridor with no incidents occurring between Coalition Forces and Iranian units. JOUETT's complete and consistently accurate air coverage for BG Delta allowed CVW 14 aircraft to carry out their cyclical combat air patrol missions into the Arabian Gulf. The subject of intense media coverage, JOUETT escorted INDEPENDENCE through the Strait of Hormuz and into the Arabian Gulf, the first such evolution since 1974. This landmark operation proved that Carrier Battle Groups could operate in the Persian Gulf, a critical factor during later operations. RADM Unruh, COMCARGRU ONE, remarked, "Well done on superb escort of INDY throughout Arabian Gulf OPS. Your professionalism and good seamanship were impressive.

- b. October 1990 JOUETT's motto of "Eternal "igilance" was also carried out in the ASUW role. JOUETT participated in the interception operations of surface traffic in support of economic sanctions against Iraq. With the use of shipboard assets and the embarked SH-2 LAMPS MKI helicopter to identify over 1000 vessels entering and leaving the Gulf of Oman, as alternate Force Over the Horizon Coordinator (FOTC) JOUETT provided an up to date tracking picture of surface units in the area in support of the Maritime Interdiction Operations. JOUETT's Outboard, acting as net control afloat for a multinational intelligence effort, provided valuable locating data and intelligence regarding Iraqi merchants in support of U.N. Maritime Sanctions.
- c. November 1990 Received a BZ from VADM Mauz (COMUSNAVCENT RMG 081917Z NOV 90) "Your impressive capabilities and flawless performance have been instrumental in the achievement of our mission in the most demanding operational environment. You can justly be proud of a job well done."

- e. February 1991 Entered Continental Maritime for SRA, ensuring material standards are at their peak.
- f. May 1991 JOUETT's critical role in providing unparalleled AAW support to Battle Group Delta resulted in the Battle Group receiving Commander Seventh Fleets AAW Award for Excellence. RADM Prueher stated "You have met every challenge with spirit and dedication. Pass on my personal well done to every officer and sailor who made it happen."
- g. August 1991 Chosen as the test ship for the first Harpoon Blk 1-D Missile Shot, CNO Project 180-2.
- h. August 1991 Outboard conducted tests on new Mobile HFDF System, providing CINCPACFLT with valuable data on systems future employment and viability.



- 4. The following accomplishments are worthy of mentioning for fiscal year 1991:
- a. Combat Systems Department was able to maintain it's ability to put "Ordnance on Target"during Refresher Training. In the areas of ASW, JOUETT successfully fired a SVTT shot, RTT shot (Excellent) and LAMPS MK I drop (Excellent) against a MK 27 target. In the AAW role, JOUETT successfully fired an SM-1 against a target flying a low profile. JOUETT's 5 inch gun mount also proved effective by performing superbly in it's engagement for REFTRA '91.
- b. JOUETT was able to maintain full certification in all applicable areas in Aviation Operations. The flight deck and aviation facilities were always available for scheduled flight OPS as well as on request for DLQ's and HIFR's. By flexing the embarked air asset, JOUETT was able to conduct a variety of operations in support of OPERATION DESERT SHIELD. With only like months of flight deck operations with a detachment in over ten years, JOUETT and HSL 33 DET 9 set a new standard for safe LAMPS Helicopter operations in the Pacific Fleet. The ship and detachment conducted nearly 2000 flight deck evolutions and accumulated over 566 flight hours without a single incident. JOUETT was able to complete well over 500 landings and the flight deck crew handled over 970 vertrep loads during WESTPAC/OPERATION DESERT SHIELD deployment. During this entire trying period, the safety record of the JOUETT, regarding all facets of flight operations, remained unblemished. During two inflight emergencies the JOUETT was able to respond and recover the embarked aircraft without incident.

- c. In the area of Dental preparedness, JOUETT underwent a Dental Readiness Evaluation in August 1991. JOUETT received an overall rating of C-1. The inspectors found that JOUETT Medical Department was enforcing a strong Dental Program. They were impressed with the Dental Program in effect and the Medical Department overall.
- a. JOUETT received the following equipment upgrades during its inport period which have significantly increased her Navigation, OTH-T, and Communications capabilities:
- (1) WRN-6 installation greatly up graded the ship's Navigation capabilities. The system accurately locates the ship to within yards of her location anywhere in the world.
- (2) Local Monitoring System upgrade introduced the latest receivers into Outboard to ensure the enhanced timely processing of signals of interest to associated equipment for OTH-T against Targets of Interest.
- (3) The UGC-143 installation incorporated the newest communications teletype and processing equipment currently available. This upgrade has already proven that it drastically reduces message processing and handling time, ensuring rapid dissemination of combat and regular record traffic.
- b. JOUETT has also established the standard for preparation. Homegrown plans of actions and milestones were the cornerstones in professionally scheduling and executing successful events such as Fast Cruise, Dock Trials, Sea Trials, Aviation and Harpoon Certifications, and Refresher Training.
- c. JOUETT'S unparalleled desire for success is evident in many areas of self sufficiency. Of note, though, was her depot level repairs to the MK 45, 5"5 Gun Mount that suffered a casualty during REFTRA. Through determination and around the clock efforts JOUETT was able to repair the system and successfully carry-out the following week's gun shoot. Never letting Logistics prevent Operational Readiness, JOUETT is always Combat Ready.
- of the ship's track record, which is commitments met and objectives fulfilled, on time. In the past fiscal year JOUETT experienced steady and consistent improvement in all areas of shipboard life. JOUETT maintained consistently high standards of readiness throughout the deployment, aggressively pursued duties as AAWC for Battle Group Delta, and demonstrated a consistently high level of professionalism in Battle Group Operations and Tactics. In homeport, JOUETT completed a most vigorous post deployment SRA with flying colors and has aggressively attacked the interdeployment workup schedule. In every evolution JOUETT had demonstrated the utmost in professionalism, attention to detail and "Cap Do Spirit". The self assurance displayed by JOUETT comes from doing the job right the first time-and every time. A recognized leader on the waterfront, USS JOUETT merits serious consideration for The Coveted Arleigh Burke Award.
